



ZeroFOX applies Risk Ratings to each rule or rule group within a policy. To start generating alerts for a particular rule or rule group, change the Risk Rating from "Off" to "Critical," "High," "Medium," "Low," or "Info."

Entity A person, place, event, or brand configured for protection in the ZeroFOX Platform. Keywords, images, and domains comprise entities and are used by the ZeroFOX Platform to collect relevant social and digital data.

Takedown The act of removing content, profiles, or pages from social and digital channels. Takedowns are always subject to each social network's Terms of Service agreement and the removal processing time varies by network.

Perpetrator The profile of a user associated with the offending content of an alert.
